

## Spring 2024 Tuition Installment Payment Plan Contract- Undergraduate

The \$67 mandatory Student Health Service Fee, the \$56 mandatory Student Mental Health Services Fees, and the optional \$2 Student Representation Fee, along with the \$33 non-refundable administrative fee are included in the first installment.\*

## This contract is subject to the following provisions:

- 1. This contract must be submitted with the 1<sup>st</sup> installment shown below.
- 2. A \$33 non-refundable administrative fee is required.
- 3. Reminder notices for the monthly installments (see below) <u>will not</u> be sent to students. Payment of each monthly installment will be the responsibility of the student whose signature appears on this contract.
- 4. A \$20 administrative late fee will be assessed for each installment paid after the due date.
- 5. Failure to fulfill this contract and remit this debt to the University when due may result in the debt being assigned to a collection agency and submitted to the Franchise Tax Board for an intercept.
- 6. CSUMB reserves their right to refuse future Payment Plan services for accounts not paid on time and/or with two or more delinquencies.
