Exec Board recommendation to update bylaws to align with OSU audit findings as follows: Article 4.1 Powers

(c) The Board shall, in collaboration with the OSU Director, develop, review, adopt, and provide oversight of policy, budget, and major transactions of the Otter Student Union. The Board shall review and approve the annual budget for the Otter Student

Union in accordance with university procedures at the Annual Board Meeting. The budget shall be proposed by the Budget Committee as set forth under Section 5.4.

Section 5.4 Budget Committee

The Budget Committee shall be composed of the OSU Director, the Treasurer, the VP of Student Affairs, and the Chief Financial Officer (CFO) or designee. The budget committee shall work to develop a proposed budget for the Otter Student Union for the next fiscal year and shall present the proposed budget to the Board for consideration and approval as defined in Section 4.1. This committee will also consider any other financial matters that may arise and make recommendations to the board.

Babita Gupta inquires about when the annual review would take place. Jeff Rensel explains that the meeting date is TBA but that the review would take place prior to a general board meeting, and policies are continuing to be established for the following years.

John Fraire adds that the budget will be most dependent on enrollment.
