 - i. <u>2024-2025 OSU Budget Proposal</u>
 - ii. Proposed budget for 2024 will be \$1,830,000.
 - 1. Various things such as fluctuations in student enrollment, increases in operating costs, and inflation across various sectors have impacted the budget.
 - a. The proposed budget assumes a net revenue from student union fees with scheduled OSU construction bond payment and associated fees assessed/administered.
 - b. The proposed budget assumes that all full-time employee positions are filled.
 - c. The target minimum Operating Reserve Fund is equal to one month of operating expenses.
 - d. With the proposed budget the OSU will continue to use the student fees it collects and operate to provide resources to the students on our campus.
 - iii. Vote for 2024-2025 OSU Budget.
 - 1. Jeff Rensel motions to approve the proposed budget.
