V. BUSINESS ITEMS

i. OSU Board Retreat - review of 2022-2023 priorities/initiatives-discussion

Jeff Rensel thanked the board for attending the retreat and contributing to productive conversations. Additionally, he created a document for the 2022-2023 priorities/initiatives.

Andres Mena introduced each priority and initiative and asked for discussion and input Campus food options-Jeff Rensel provided an update on dining updates including the Boost app, which facilitates food orders and is open to everyone. Moreover, campus dining is looking into keeping the sea store open longer. Jeff suggests inviting campus dining for further updates. Campus dining has some marketing on their recent updates on social media and with table tents in the Forager's Cove. Patterson asked about a space to lock the ghost kitchen orders and Jeff will follow up.

History of OSU/activities- Andrew suggests possibly using the Black Box Cabaret as an option to display this history of the OSU. Jeff informs the board that Karina (OSU marketing) can help on this project.

Charging stations at the OSU- Kassie explained her vision of having laptop charging stations in the OSU.

Additional seating options at The Bayview Terrace (3rd floor of the OSU)- Jeff informed the board the OSU staff is looking into additional seating options for the building.

Student organizations not knowing about the OSU and its amenities- Jeff suggested that the OSU Operations Specialist help with student organizations outreach and get SELD involved in this outreach effort.

Art and featuring local artists at the OSU- Jeff recommends creating an art advisory committee that can assist in this initiative. The Otter Cross Cultural Center helped bring art to the OSU last semester. Dylan mentioned that Monetery has local art galleries and it would be beneficial to reach out and see if they're interested. Conversation about how creating a subcommittee would be beneficial and Jeff clarified that advisory committees of the board can be established anytime, needs at least three directors, and the board needs to create a charge statement for the subcommittee.

Community garden and indoor plants at the OSU- Jeff suggests having conversations with campus partners to facilitate this initiative as they might share the same interest.

International students support- Andres highlighted the lack of support for international students at CSUMB. Would like to collaborate with international student departments for a waiting area, luggage storage, and support when moving to CSUMB. Patterson mentioned his position as a resident assistant and can assist in leading this initiative.

Family friendly spaces in the OSU. David elaborated on the lack of family friendly study spaces in the OSU.

Permanent gender neutral signs educating people on the why- Jeff volunteered himself and Karina to work on this since it has been done for bigger events at the OSU in the past. Signage/ information boards and another TV for student organizations only to promote their efforts.

Andres suggests creating a poll of the priorities/initiatives and have the board vote on their top three. Jeff recommends that the executive board create the poll and send it out to the

board. Additionally, Jeff clarified that some of these are part of the OSU staff's responsibilities and we can report back to the board with any updates and progress.
